

# MODEL RELEASE AGREEMENT

## A. Definitions

In this Agreement, the words "I," "me," and "my" mean "\_\_\_\_\_".

"It" means Granity Entertainment, DAC (hereinafter, "Granity").

"Users" means Granity, its assigns, licensees, agents, employees, representatives, those acting with its permission and authority, those for whom it is acting, and their agents and employees.

"Images" means any photographs, digital or otherwise, video or video stills, live-streaming broadcasts via Internet, prints, negatives, pictures, designs, of every kind.

"Media" means any website or other means of Internet publication or so-called "social media", CD-ROM, DVD, videotape, digital video, movie, motion picture, streaming video, any advertising or promotional material, magazine, book, and any other means of publication available now or in the future.

## B. Terms of This Agreement

In consideration of my Images being exposed **solely for the Cam4 Pornhub channel (hereinafter, "the Purpose)**, I hereby grant to Granity and Users the irrevocable and unrestricted right and permission to copyright in Granity's name or any other, sell and resell, license, publish, print, broadcast, exhibit, display, and use for the Purpose, any Images in which I am included in whole or in part, supplied by me to Granity or taken at any time by Granity, its employees, agents, contractors and/or assigns

## C. Waiver of Right to Approve Use of Images

I hereby waive all rights that I have to inspect or approve the Images, the editorial or advertising copy, any printed matter, pictures, or any other material that may be used by the Users in conjunction with the Images. I also waive all rights that I have with respect to the use of the Images by the Users, without restriction as to changes or alterations, in conjunction with my own or a fictitious name, with fictitious or accurate biographical material, with material of an explicit sexual nature, alone or in conjunction with any printed matter, images, or any other material, for the Purpose.

## D. Waiver of Right to Hold Users Liable for Any Use of Images

I hereby release, discharge and agree to hold harmless the Users from all liability resulting from any use of the Images for the Purpose, even if such use would subject me to ridicule, scandal, reproach, scorn, or indignity, including without limitation any claims for libel or invasion of privacy, and from any liability resulting from any distortion, blurring, alteration, optical illusion or use in composite form, either intentionally or otherwise, that may occur or be produced in taking, processing, reproducing, publishing, distributing or otherwise using the Images.

**E. Relationship of the Parties**

The parties to this Agreement intend that an independent contractor relationship will be created by this Agreement, and that no partnership, joint venture or employee/employer relationship is intended.

**F. Governing Law and Venue**

This Agreement shall be governed by the laws of the country of Ireland. Venue for any action under this Agreement shall be in Dublin, Ireland.

**G. Attorneys' Fees**

If a legal proceeding is commenced to enforce or obtain a declaration of rights under this Agreement, the prevailing party in such proceeding shall be entitled to recover its reasonable attorneys' fees and costs incurred in the proceeding from the nonprevailing party, as well as any reasonable attorneys' fees and costs that the prevailing party incurred prior to commencing the proceeding.

**H. Scope of Agreement; Severability**

This Agreement is comprehensive and constitutes the entire agreement between me and Granity. No other promises, express or implied, have been made to me by Granity or by anyone associated with, or claiming to be associated with, Granity. Any modifications or additions to this Agreement must be in writing and signed by both parties. If any provision of this Agreement is unlawful, void or unenforceable, then that provision shall be deemed severable from the remaining provisions and shall not affect the validity and enforceability of the remaining provisions.

**I hereby represent and warrant that I am at least eighteen years of age or older, that I was eighteen or older when the Images were produced, and that I have the right to contract in my own name. I agree to keep all records required by Title 18 USC 2256, 2257, and 2257A and 28 CFR Part 75, sections 75.1 through 75.9, and to provide Granity with copies of same.**

**I have read this Agreement prior to its execution, and I agree that it shall be legally binding upon me and my heirs, legal representatives, and assigns. I have not been induced to sign this Agreement, other than by the consideration recited above in Section B, by any representations or statements made by Granity, by anyone acting on its behalf, or by any other person.**
